The Promoter

1. The promoter is Bayer New Zealand Limited (company no. 17012) of 3 Argus Place, Hillcrest, Auckland 0627, New Zealand (**Promoter**).

Conditions of entry

2. Information on how to enter the Win a Saddle Facebook promotion (**Promotion**) and on the prizes forms part of these terms and conditions. Participation in the Promotion is deemed acceptance of these and any other applicable terms and conditions (together the **Terms and Conditions**). Any entry not complying with the Terms and Conditions is invalid.
3. Entry into the Promotion is open to New Zealand residents who are aged 5 years or over provided that any entrant who is under the age of 18 must be accompanied by a guardian or parent of such person.
